**Overall Objective** – The UDSMP-U and executive summary should provide stakeholders (e.g., developers, lenders, property owners, City staff, elected officials, community members, etc.) the information they need **to know** and **to do** what is necessary to develop the University District and to achieve the UDPDA/UDDA's thematic goal\*. We want to change behavior, e.g., faster, better, more efficient/coordinated.

Audience	What should they know	What should they <b>do</b>

**Timebound Objectives** – The following are critical inputs, activities, or outcomes that are essential or expected if we have effectively engaged the relevant stakeholders:

#### Immediate (within 2 years)

- Clear value proposition and direction for developers on preferred development types, development mixes, and cost/revenue thresholds.
- o Clear insight on design standards/preferences and development barriers in South Subarea for the City to address in a subarea plan.
- o Remove uncertainty regarding area's vision and potential.
- o Highlight and promote highest priority development types and locations.
- o Initial aggregation, clean up, planning/sale of prime sites.



o Ensure remaining 2004 catalytic infrastructure projects are started, funded, or included in integrated capital plans and budgets.

## Midrange (3-5 years)

- o Metrics to track how strong development is faring.
- Metrics to evaluate the absorption of recent development and to evaluate new opportunities.
- o Aggregation, clean up, planning/sale of secondary sites.
- o Identification of catalytic infrastructure and services that will support continued investment and development.

## Longer-term (5 years +)

- Aggregation, clean up, planning/sale of secondary sites and redevelopment of underutilized but active sites.
- o Greater densification and diversification of uses.

#### **UDSMP-U General Timeline**

- March 5 UDPDA board meeting Chair will ask for a MOTION to authorize the CEO to finalize the updated UDSMP-U and executive summary and send to the City Council for review/vote.
- March-April City Council reviews/votes on updated UDSMP-U.
- **April-June** City begins subarea planning that will guide future use and development standards.
- June 4 UDPDA board meeting City provides an update on subarea planning;
  DC reports to UDPDA board on progress.
